FIRE DEPARTMENT COVERAGE AGREEMENT**

\*The Town of Herman has its own Fire Department together with the Village of Gresham and the Town of Red Springs.

\*No citizen of the Town of Herman shall call 911 and request the Pella Fire Department except for: 1) those owning property in Sections 31 and 32 surrounding the unincorporated village of Leopolis; 2) those owning property on the north side of Pevonka Lane in Section 30; and 3) those owning property on Cedar Lane in Section 34.

\*The Town of Herman is responsible for paying the Pella Fire Department any costs incurred that are not covered by the property owner's insurance. This applies to each fire call in the above-mentioned areas.

\*If the Pella Fire Department needs assistance at a major or structural fire call in the above-mentioned areas, the Pella Fire Chief will call on the Gresham Fire Department for assistance.

\*This agreement also includes the Pella First Responders/Pella EMS.

This has been reviewed and approved by both the Town of Pella and Town of Herman boards.





Adopted June 4, 1990

WHEREAS, the Town of Herman has its own Fire Department together with the Village of Gresham and the Town of Red Springs and,

WHEREAS, no citizen of the Town of Herman shall call the Pella Fire Department except residents in Section 31 and Section 32 surrounding the unincorporated Village of Leopoldis,

WHEREAS, the Town of Herman agrees to pay the Pella Fire Department the first \$250.00 on per fire call in said Section 31 and Section 32. Balance of fire call will be paid by property owner,

WHEREAS, if Pella Fire Chief needs assistance at a major or structural fire call the Gresham Fire Department must be called.






