

Town of Herman Monthly Board Meeting

July 14, 2015

The monthly meeting of the Town of Herman was called to order at 7:00pm by chairman, Joe DeBaker. Present were Chairman Joe DeBaker, Supervisor 2 Howie Schultz, Treasurer Robert Traeger and Clerk Lori Schmidt.

The Pledge of Allegiance was recited by all present.

A motion to approve the Agenda was made by Joe, second by Howie, voice vote 2-0 in favor, motion carried.

A motion to approve the Minutes from the previous meeting by was made Howie, second by Joe, voice vote 2-0 in favor, motion carried.

Public comments were presented to the board regarding the mowing of our town roads not being done properly. Also some of the town's road did not get mowed at all. Joe states he will contact the highway commissioner.

Correspondence were reviewed.

The Finance Report was presented to the board by Bob for the month of June Income \$1,674.54, Checking balance \$11,281.07, MM \$188,311.40. A motion to approve the finance report was made by Joe, second by Howie, voice vote 2-0 in favor, motion carried.

The July payables was presented to the board by Lori. A motion to approve the Payables as presented was made by Howie, second by Joe, voice vote 2-0 in favor, motion carried.

A motion to have the county to do tree trimming along 3rd St, Leopold Rd and Water St was made by Howie, second by Joe, voice vote 2-0 in favor, motion carried.

Joe reported on the Milfoil project on the Leopold Pond. Joe states he dropped the level of water in order for volunteers to pull the milfoil and only 1 patch of milfoil was found. Joe recommends to stop payment on the \$600.00 check for permit since it is no longer needed. Further discussion took place. It was decided that this subject will be tabled until the August meeting.

Sign needs to be ordered for W11200 Sunrise Rd for Robaidek's driveway/culvert and building permit has been obtained. They intend to move a shed on the property. Also a discussion took place regarding driveway put in on Willow Rd.

A discussion took place regarding the Shawano County Landfill. Joe wrote to Christa Hoffman a representative of the County. A letter was read from Christa stating that the Town of Herman was not under contract. She further states that in 1999 other Townships signed the contract but not the Town of Herman. A copy of the letter will be filed with the minutes.
